The Andersons MicroBlitz® fertilizer is a professional-grade nutrient package suited for use on all plants. It provides nutrients that are essential for maximizing fruit and blooms. MicroBlitz also contains fulvic acid to enable immediate uptake of applied nutrients through the leaf surface.

DIRECTIONS FOR USE

Shake bottle of MicroBlitz before use.

Attach the sprayer head attachment to a garden hose.

Position the sprayer head attachment to the “on” position, turn on water.

Wet the leaves and the stems of desired plants with the foliar spray solution. With the sprayer hose attachment set to the “water” position, spray the base of the plants until soil is saturated.

Finish spraying by positioning the sprayer head attachment to the “off” position and disconnect sprayer from hose.

For best results, apply every 7 to 14 days. 32 oz of MicroBlitz feeds approximately 5,000 square feet of garden/lawn area and will provide 12-15 minutes of continuous feeding. Do not apply to lawns more than 12x per year in Florida.

Use only as directed to avoid foliar burn. Do not apply when temperature is above 85°F. Do not allow to freeze. Do not mix with calcium-based fertilizers.
